
Firebreak Electrical Box Protectors

TECHNICAL DATA SHEET

Firebreak Electrical Box Protectors (Putty Pads) are designed to reinstate the fire resistance of partition walls where fitted with electrical socket and switch boxes.



Description

Fire resistant partitions rely on the combined fire resistance performance of the facing material, usually plasterboard, of both sides of the partition. When electrical socket and switch boxes are fitted it requires an opening to be cut in the facing material thereby creating a weak point which compromises the overall fire resistance performance of the partition.

Firebreak Electrical Box Protectors are formed from a silicone based intumescent polymer with additional fire resistant additives and are designed to be fitted either inside the electrical box to form a lining or as needs arise to form a cover over the back of the electrical box.

The material is non-setting and easily mouldable by hand ensuring quick and easy

installation. Under fire conditions the intumescent filler in the putty expands to many times its original thickness to form a dense block of fire resistant char thereby maintaining the fire resistance performance of the partition and preventing the spread of fire.

Characteristics and performance


Firebreak Electrical Box Protectors are tested to the latest European fire test Standard for applications in fire resistant partition walls.

- Fire testing to the general principles of BS EN 1364-1: 1999 in conjunction with additional guidelines from BS EN 1366-3: 2009
- Fire Classification to EN 13501-2 and CE Mark (ETA 17/0779)

- Flexible Walls (stud partitions) of 130mm minimum thickness
- 120 minutes fire resistance
- Specifications for non-insulated partitions
- Testing undertaken using double switch sockets with plastic back boxes
- Tested with sockets located back to back or in close proximity on both sides of the partition
- Pre-formed pads with peel away paper facings for simple installation without the need for specialist tools
- Non-setting, allowing for easy modification of electrical wiring without the need for the fitting of a replacement pad

- Ensure contact surfaces for the pad are clean and free from loose materials
- Seal any gaps between the back box and partition facing sheet using Firebreak 22
 Fire Resistant & Acoustic Sealant
- Fit all necessary electrical cables within the back box
- Select the correct size of pad and make a small split(s) in the pad to allow for fitting around the cables(s)
- For application to the back of the box, locate the pad centrally and press firmly to the back and sides of the box and to the back face of the partition around the perimeter of the box to form a complete seal including around all cables

- Ensure that none of the surface of the box is left exposed
- For application to the inside of the box similarly locate centrally and press against the back and side surfaces of the box ensuring a complete covering and tight seal around all cables
- Excess material can be trimmed away as necessary using a sharp knife or simply folded back into the box if space allows
- Complete the electrical connections as required and fix the switch/socket plate in place in the normal manner

End use considerations

Whilst Firebreak Electrical Box Protectors are intended for internal use they are not affected by moisture.

Maintenance

No routine maintenance is required.
